CONVENTION NEWS...It'll Be Here Sooner Than We Think (7 weeks)

FLASH! Carat Vallee has worked long and hard to convince REPUBLIC Airlines to provide service charge-free passes for all ISA members who are furloughed. THANK YOU CARAT AND REPUBLIC for your generosity! (All eligible ISA members have been previously contacted...if you haven't received a letter, contact Carat ASAP.)

This year's ISA convention (our 7th!) will be held at the Holiday Inn Crowne Plaza (formerly the Park Hilton), Sixth Avenue at Seneca Street in downtown Seattle, May 8th through 10th (that's a Tuesday through Thursday). Plan to arrive early on Tuesday to enjoy a leisurely afternoon of renewing old friendships and making new ones. The hospitality suite will open Tuesday at 1:00 pm...check with the front desk when you arrive for the exact room number...where we'll be registering and welcoming each member.

Those members wishing to share hotel rooms, please mark the box on the reply card so we can keep track of 'roomers' and 'roomees'. We'll be assisting with the matching process in the hospitality suite.

Due to the economic squeeze on all of us, our convention will be self-sponsored this year and there will be a \$25 registration fee to cover the cocktail party and brunch fees. Keeping in mind that we are a professional association, perhaps your tax advisor will look kindly on your 'contribution.'

SOME IMPORTANT POINTS TO REMEMBER:

- 1) Bring your FULL UNIFORM, including the HAT...which, along with your numbered name tag, will be your ticket to the business meeting on Wednesday.
- 2) Cameras are always welcome along with any photos from previous get togethers you'd like to contribute to the scrapbook (see Norah O'Neill). We will have a professional photographer to take group and special request shots, but suggest you bring your own for candids.
- 3) T-Shirt/Logowear Swap. Bring an item of clothing (caps, shirts, or whatever) with your airline's logo on it to trade at the swap session. You'd be amazed at what super items you come across!

HOTEL CARDS ARE ENCLOSED so you can make advance reservations with the hotel. A Word of Explanation: the cards are the standard ones hotels use to secure reservations, hence a few misleading items. First of all, our rate of \$45 single and \$50 double is guaranteed to our members so disregard the information in the upper right box. They do want your reservations as soon as possible, so TRY to get them in by April 8th. Yes, it $\frac{is}{100}$ early, but they do not require a deposit and will hold rooms until 6:00 p.m. on the night of your arrival without any advance fees.

For those of you who are going to arrive late, or don't know if you'll be able to attend, we suggest you reserve anyway and cancel at the last moment if you can't make it. You would do well to guarantee your reservation with a credit card...it can always be cancelled if your

plans change by using their toll-free number (800/521-2762 outside Washington, 800/858-0511 in Washington).

GETTING TO THE HOTEL: When you arrive at the Sea-Tac airport (recently renamed Henry Jackson Field, I think), check in the baggage area for the limo (a large bus) to downtown Seattle. HOW IT ALL BEGAN...The Real Story of ISA's humble beginnings as related by Mary Bush Horton.

For some time, I had entertained the idea of forming some type of organization so we could all meet each other and swap stories once a year. I thought this would be a perfect opportunity to present my idea.

So, after the dinner meeting Zonta held, when all of us girls got toether in one of our rooms, I made the suggestion. It was warmly received and after kicking it around a bit we decided to meet in May in Las Vegas.

We divided up jobs with Bev [Bass Harber] and Steph [Wallach] doing the mailings since they lived so close and were friends. I was to arrange for a place to have it. Las Vegas was chosen because I lived there,

and had initially suggested it.

Attending that meeting were Terry Rinehart, Beverley Bass, Steph Wallach, Charlotte Wall, Denise Blankinship (I think, but maybe not) Jackie Gerber from Ozark, Mary Hirsch from Continental (?) and myself.

I went home to set up the meeting and I believe that same week I flew with a Captain who told me of Claudia Jones and how she had just gotten hired by Continental. I called her, introduced myself and told her why I had gotten in touch. She was very receptive and said she would love to help.

Claudia set up a luncheon meeting with a top executive at Circus Circus who she knew from her entertainment days. We met and he showed us some really lovely rooms and said we could use them, and that they would be happy to have us.

Then we all got busy telling everyone we knew of flying for an airline to come. And that's the story."

SPEAKING OF STORIES...

The following story appeared in the Style section of the New York Times of January 20, 1984.

"Some time ago, Donald Trump, of the real-estate empire, was having his photograph taken at the Bachrach studio and mentioned that when Trump Tower was completed, he like to use it for an exhibition of portraits. "We've never had a pregnant pilot before," he said.
