#### ISA INVITED TO MEET WITH FAA OFFICIAL T. ALLAN MCARTOR

Head FAA administrator T. Allen McArtor has invited the ISA members to meet with him in Washington, D.C. and to talk with him about our industry concerns and the issues of today, followed by a tour of Smithsonian's Air and Space Museum.

Air and Space Museum.

Whenever.....Back on the Metrorail at L'Enfant Plaza
Station (directly behind the Smithsonian)
for transportation back to Washington
National for your flight departures.

Since it is quite an honour to be invited to meet with the FAA Administrator and to tour his facility, we would certainly hope to have a good turnout. Washington National is an easy airport for most of our pilots to get to, and the city's Metrorail makes getting around the city easy as well as economical.

Hotel suggestions: Downtown accommodations are relatively expensive, often \$90 to \$125 even with our airline discount rate. However, if you've never been to Washington and are interested in having the Washington Monument outside your window, then you may consider it an experience! Hotels nearer to the airport are less expensive and are accessible by the Metrorail system. Downtown: Capitol Hilton, J.W. Marriot at National Place, Hotel Washington.

Airport: Stouffer Concourse Hotel, \$59 single or double; Marriot Twin Bridges, \$55 single or \$59 double; Howard Johnson Nat. Airport Hotel, \$50 single or double.

#### ISA + 21'S 1989 MIDWINTER GET - TOGETHER

### JANUARY 24 - 26 , 1988 WHISTLER, CANADA

SKIER'S SPECIAL! This year's ISA ski get-together has been organized by Kathy Zokol of Canadian Airlines, to take place at Whistler, B.C. Canada. The village of Whistler is about two hours' drive from Vancouver, B.C. and offers two fantastic ski areas: Whistler and Blackcomb. A Whistler mountain brochure is enclosed to pique your interest; the adjacent Blackcomb mountain offers over 5000' of vertical, 9 chairlifts, 1 T-Bar, 1 handle tow, 2 on-mountain restaurants, and a great apres-ski bar at the bottom of the hill. Both mountains offer beginner to expert downhill skiing, cross-country skiing, guided mountain tours, ski rentals and lessons. There's a great waterslide/hot pool facility in town for after-ski fun as well as lots of restaurants, shops, and night-life.

We plan to travel from Vancouver to Whistler on Tuesday the 24th, ski Wednesday and Thursday, and return to Vancouver Friday. Transportation will be by car pool, express bus, and/or train - there's lots of transport back and forth every day. We'll be staying at a rented house that can sleep up to 20 and is within minutes of the mountains and Whistler village. Cost will be \$10-15 per night (Canadian funds - about 20% less than U.S.\$), depending on the number of people who stay. There is a second rental house available to us next door if we need it.

Ski lift tickets are around \$33 CDN; if we get 15 or more people we can reduce that cost considerably. Accomodation will be first come, first serve - and the sooner we can get people committed, the more likely we'll be able to organize some fun group events like videotaped ski races, on-mountain picnics, etc., as well as the reduced-rate lift tickets. And ISA moms - kids are welcome at both Blackcomb and Whistler (see "Family" column).

Finally, if you're not into skiing or just want a quiet couple of days to visit with your ISA friends - or make some new ones - you'll find Whistler is a great place to be as well. The valley has lots of walking trails and gorgeous scenery to enjoy, there's shops to browse in the village, and Whistler mountain has a new high-speed, fully enclosed gondola car to give non-skiers (or skiers) a comfortable warm ride to their mountain-top restaurant.



Norah O'Neill was the first 121 female cargo pilot, hired back in 1976 with Flying Tigers. Today, more than 100 women fly for these prosperous and successful carriers. Federal Express prides itself on having the largest percentage of women pilots in the entire airline industry. Southern Air Transport's Linda Pauwels just became the youngest female Captain when she upgraded to the left seat of the Boeing 707 at age 25! U.P.S. is actively hiring women to join the ranks of their newly-formed company. Emily Warner, the first female airline pilot in the U.S., is among their newest B727 Captains.

Talk to one of these cargo pilots and you'll find that the flying they do is very challenging and exciting. It consists of far-away places with strange-sounding names, exotic cargos and crazy hours. When the rest of us are calling it a night, they're just checking in for the night. Here's our salute to you!

The worst part is not knowing who did it or why - you must have felt considerable hurt, and perhaps even fear. And that is the hoped-for result of such a vicious act - to upset your sense of security in the workplace and fill you with fear and paranoia. Professionalism is abandoned when people express their frustration and anger in such inappropriate, destructive ways.

You were wise to report the incident to your flight manager. It could result in an official "security memo" sent out to all pilots in your domicile, which would have a discouraging effect on future acts of vandalism.

It may be hard to do at first, but a pleasant greeting and a "business as usual" demeanor to everyone you meet on the job will speed up the healing process and show the perpetrator how ineffective the prank was. Also, an unlabelled garment bag with a small suitcase-type lock might help you feel a lot more comfortable.

(ed. note: the following is the opinion from one of our readers written in response to a letter signed "Worried", that appeared in the March 1988 Dear Amelia column. "Trying to Stay Alive" obviously disagrees with Amelia's previous advice to "Worried"!) Dear Worried: You have every reason to be worried! Although the FARs may list the Captain as the "primary" person responsible for the flight, experience has shown that the FAA considers all required crewmembers responsible for what happens on a particular flight.

This was brought home to me on my very first flight with my previous commuter airline on a charter flight to a small airport in Utah. When the Captain broke out of the clouds and declared he "had the airport", I believed him - thinking he had recognized it. Fortunately, on final I noticed there were no VASI lights and the buildings did not correspond to my chart. When the FAA investigated a passenger's report, they made it very clear that we BOTH would have been charged had any regulations had been violated. Luckily it never came to that. Remember, from day one you are considered to be a required and qualified crewmember, and it is your responsibility to bring any impending infringements on the safe or legal conduct of the flight to the Captain's attention. To the extreme, this may include taking the aircraft away from the Captain if the safe conclusion of the flight is in question. As flight crew members, we should always verbally air our views concerning the safety of the passengers, the airworthiness of the aircraft, or the legal That is our ultimate responsibility protection of our licence. and what we are being paid for, as far as I am concerned. There are no "gods" in the cockpit - even if a person is wearing 4 stripes. Holding your tongue just might get you killed!
