

ROME CONVENTION IS A SUCCESS

On Tuesday, May 10, 1988, ISA + 21 held their llth Annual Meeting in Rome, Italy, sponsored by Agusta helicopters, Aeritalia, and Alitalia. Our hostess for this meeting was Fiorenza de Bernardi. Sixty members joined together in Rome for fun and frolic, as well as three hours of business on the morning of May 11. The minutes of this meeting are included in this Newsletter. During the luncheon on May 11, ISA thanked our hostess with a silver "Nambe" platter from Santa Fe, New Mexico. Fiorenza's helpers each received a gold "Cross" pen. Their help in this convention was invaluable. We also honored those members who in the last year earned their left

seat checkout. They are.....

FOR YOUR INTEREST.....

Some facts on pilots in Canada: With a total population of around 26 million, there are 6940 males who hold Airline Transport Ratings, and 95 females. That is, 1.35% of the ATR pilots in Canada are women. There are about 3500 pilots flying with major airlines in Canada (i.e. with either Air Canada, Canadian Airlines International, or Wardair). Twenty of these airline pilots are women, i.e. about .56%. Thirteen women fly for Air Canada, seven for Canadian Airlines, and none for Wardair. The first woman airline pilot in Canada was ISA member Rosella Bjornson, hired by Transair (now part of Canadian Airlines International) in We don't yet have a 1973. woman flying as a Captain for a major airline in Canada. Statistics Canada reports that in 1986, the occupational category of "Air Pilots, Navigators and Flight Engineers" was the 6th-highest paid occupational category for males in Canada (using average salaries in each occupation). The average age of a male in that occupational category was 39.7 years and the average salary for the category \$57,337. (The average male salary for all occupations in Canada was \$30,504; the average male worker's age overall was 39.7 years). In 1986, the average wage for females in the "Air Pilots, Navigators and Flight Engineers" category was \$27,436; the average age of the female in that category 34.9 (The overall average wage for females was \$19,995; the average female worker's age was 37.2 years).

As an aside, the highest-paid category for males was that of "doctors" and for women it was "judges and magistrates". These stats refer only to full-year, full-time workers, and all figures are in Canadian dollars. Sources: Financial Post, Canadian Aviation, Statistics Canada.

COLD LAKE, Alta. — The first two women to train as fighter pilots for the Canadian Forces started the basic fighter pilot course Monday at Canadian Forces Base Cold Lake, Alta.

Capt. Deanna Brasseur, 34, and Capt. Jane Foster, 27, with 15 male counterparts will spend the next seven months training on the CF-5 Freedom Fighter.

In 1987 all restrictions on employment of women in the Canadian air force were lifted and women may now apply for any jobs for which they meet the requirements.

I have also received many requests from members for copies of policies from various airlines, so in the upcoming ISA magazine, I'll publish condensed versions of all maternity policies in my file. The women who are interested in this issue will then have their own lists of policies, and can correct any discrepancies in my information.

Recently, I discovered that ALPA National supports women pilots flying while pregnant. This brief statement was made policy by the 1980 Board of Directors: "ALPA opposes airline management decisions aimed at requiring pilots to terminate flying immediately upon knowledge of pregnancy." For those of you working on modifying your company's maternity policy, ALPA National's position on women pilots flying while pregnant may be helpful. In addition, Dr. Masters, ALPA Aeromedical Advisor, has supported my efforts to obtain recognition and help on this issue from my local union members, by offering to endorse my proposed resolution to our ALPA contract. I was also considering sending the resolution to the American College of Obstetricians and Gynecologists, and asking for their endorsement of its medical portion. Do any of you have an opinion about such a request?

As always, I am open to any suggestions, comments, or questions you may have. I believe that it will take the efforts of many women working together to change the very restrictive maternity policies of many of our airlines, so please stay in touch!

FIORENZA DE BERNARDI MERIT AWARD

For those of you who have not had the pleasure of meeting Fiorenza or reading Italian aviation history, let me say a few words about my good friend and some of the reasons we felt compelled to honor her with an award in her name.

Having learned to fly from her father, an aviation pioneer, Fiorenza followed his example by making history in 1967 when she became Italy's first female airline pilot. That put her in the very exclusive group of four women in all of Europe who were flying for airlines at the time. Her long-time association with other European women has continued, and she is now serving as president of the European Women Pilots Federation as well as the founder-president of the Italian Women Pilots Association. Recently she has compiled and edited a book acknowledging a wonderful history of aviation entitled "Pink Line: A Gallery of European Women Pilots". Her illustrious career has also included flying DC-8s after she was the first woman to be allowed to attend Alitalia's training center, and a presentation tour around the Yak 40 tri-jet.

Over the years she has remained a steadfast supporter of ISA and promoted our international membership. It is in part due to her efforts that we have increased our international membership this year and she organized an outstanding convention, held for the first time in Europe. Fiorenza has been lobbying for and working on this convention since May of 1985 and those of us who attended are all very grateful that she was successful.

She has spent years struggling against Alitalia's attitudes that kept her goal of flying for Italy's national carrier but a dream. An unfortunate auto accident has now meant many months of hospitalization for Fiorenza and the even more painful realization that she may never fly again. Despite her personal tragedy, she

NANCY LAW

I grew up in Knoxville,
Tennessee, where I graduated
Phi Betta Kappa from the
University of Tennessee. After
graduation I decided to take a
break from academics and
applied to Piedmont Airlines as
a flight attendant. I was
accepted and began life in the
airlines at age 21.

During the next two years I started taking flying lessons and I was hooked! I continued working as a flight attendant while earning the various necessary licences and ratings. I flew all the general aviation jobs I could, in order to build time: freight, ferrying, corporate, flight instructing, etc. I had a real break when Atlantic Southeast Airlines hired me as a pilot. There I was able to gain the hours and experience necessary to apply to Piedmont.

I was hired as a flight engineer in May of 1983. The following year I up-graded to the right seat of the B-727 and two years later I up-graded to Captain on the B-737!

I have been an ISA member since 1984 and Seattle was the first convention. Since then I have attended every meeting, except for Australia, and am thrilled to be on the Executive

Council as the new Convention Coordinator. Planning parties is certainly a fun job and it will be a challenge, as well as my pleasure, to help plan the details for our 12th anniversary! I am anxious to serve you in this capacity and look forward to meeting many new faces.

SANDRA LLOYD

A native of Vancouver, British Columbia, Canada, I started flying at age sixteen at Abbotsford, B.C., my home at that time (I think it was the Abbotsford Airshow that got me going). I loved flying right off the bat and before age 19 held Canadian commercial, multi-engine, instrument and instructor ratings. I built up time over the next three years mainly through "bush" flying jobs in northern Manitoba and in British Columbia (lots of float flying!). In 1979 at age 22 I was hired by CP Air as their first woman pilot and was trained as a DC 8 second officer. Following three years in that position and a further three years of furlough, I returned to CP Air as a DC 10 second officer. Since then CP Air has become part of Canadian Airlines International, and I have been a B-737 first officer since September 1987. I have a degree in Business Admin. and a year of law school, which I'm planning on continuing this fall. Most of my favourite leisure time is spent playing sports and being in the outdoors - and going to ISA conventions, of course!

By an amazingly unanimous decision, we selected Elizabeth Logan as our first choice. As to the merit award, most of the applicants were among the top three choices on someone's list, but the name that came up most often was Shelly Shallenberger. Elizabeth has already started on her ATP work and Shelly is considering which rating to work on next. I urge any of you who feel so inclined to contact them with your congratulations and encouragement.

Moreover, I hope we can make all the applicants turn out to be winners in their association with ISA. MOTION # 1

If men meet the same ISA requirements that our members do, should they be considered as associate non-voting members?

Discussion: According to one legal source, we could be sued because we are all female and the meaning of commerce is so broad. (submitted by Maggie Rose)

Discussion: The purpose of this motion is to establish our policy regarding male members. I see the primary goal of ISA+21 to be the support and advancement of women as airline pilots. If a male applicant, who otherwise meets our qualifications for membership, desires to support our goals then I propose that we encourage their support as a non-voting associate member. It is my belief that an accusation of discriminatory membership practices could only result if we completely exclude men directly or indirectly from ISA. Вy establishing this policy, we are not recruiting male members. On the contrary, I suggest that as long as we do not refuse membership to male applicants, their interest in ISA will dwindle. MOTION #2

Should we reconsider the requirements of needing two (2) recommendations for membership?

with me over the past two years about their interest in this project. The members of the selection committee are Angela Allen, Margaret Brewer, Rita Reo, Suzanne Skeeters, Susan Staples, and myself. Their participation has been vital and greatly appreciated.

Wanting some reliable personal feedback about the applicants, other than the three letters of recommendation that were required, I contacted ISA members, two where possible, who could meet each applicant and report back to the committee. I would like to thank each of the following members for conducting those interviews on such short notice: Regina Grisafi, Mary Bardon, Deborah Waingrow, Lori Adams, Sarah Pearl, LaDonna Shea, Binka Bone, Cammy Condon, Suzanne Skeeters, Mary Horton, Cari Wilson, Angela Allen, Gail Gorski, Ginger Mitchell, Andrea Rice, Sandra Wilson, and Susan Arthurs. We certainly could not have done it without you and your reports to us were of immeasureable assistance. These members were picked because of their proximity to the applicants and because they had indicated their interest in working on this project by returning the postcards sent out to all members.

With this done, three of us sat down in Atlanta in April, communicating with the other selection committee members by phone, and discussed each applicant as well as refinements to the application form, interview process, and basic requirements. It was decided that to limit the number of applicants in future years and to make it possible for the receiving pilot to obtain her ATP within the allotted year, that the basic flight hours would be increased to 700 hours. Because of vast differences, the foreign application would be similar but prerequisites would reflect the hiring practices in each country.

Additionally, it was agreed that to have a better basis to compare the applicants, a standard airline-type interview should be give by the ISA members. This would have the dual and important purpose of also giving all the aspiring airline pilots exposure to and practice at the type of interview they will soon be encountering the their job search.

A little information about the applicants might be of interest to you. Our ten applicants came from nine different U.S. states and ranged in age from 22 to 31 years old with flight times totalling from 300 to 1700 hours. Because half of the applicants had relatively low time (300-700 hours) and would have difficulty in completing their ATP within a year, we decided to give two awards. One would be a larger amount (\$1,200) that would be used toward an ATP rating and the other a smaller amount (\$300) would be used toward an advanced instructor rating or FE written course. All the applicants appeared to be outstanding individuals that were dedicated, conscientious, skilled, financially needy, and came highly recommended. It was a very hard decision indeed, and more than once we commented that we were glad that there were only ten applicants this year. Next year there will undoubtedly be many more, hence the need for more time (applications due by January 1st), and a more standardized interview process.

1989 CONVENTION SITE NEEDED

Efforts have also been started to try to consolidate interview tips and Sally Van de Water has contributed an article with some very good pointers for aspiring airline pilot interviewees. Career counseling has been mentioned and it might be nice to compile a brochure for the airline-bound pilot. I'm sure you all have a few thoughts on what qualities are needed and what it's like after you finally land a job. Your ideas


