



## Chair's Letter

Dear members,

This is my last quarterly letter to you as a director on ISA's Board.

## Education Chair (outgoing)

It's time for me to say farewell as Education Chair and announce the good news – we have a new education Chair! I'd like to welcome Tiffany Vlasek, a TWA First Officer who lives in San Jose, California. She was the only candidate on February 10<sup>th</sup> when nominations closed. She will take over officially on May 15<sup>th</sup> as the new Board of Directors takes office. Hopefully, Tiffany will make it to Alyeska to meet as many members as possible.

This last quarter has been quite busy with requests coming in steadily – both from members who are doing outreach at schools, colleges and other groups, and from institutions who hope we can help them in some way. Members usually request copies of our *Tips* booklet or a loan of various ISA videos. (Do remember you can download the *Tips* booklet from the website!)

From other agencies, requests have been varied. I received a request from a news producer for an educational Web site, [www.riverdeep.net](http://www.riverdeep.net), based in Cambridge, Massachusetts. They wanted to do a video interview with one or two of our pilots. Mr Schachter explained that he was working on a story about the increasing numbers of women pilots in commercial aviation. The story actually will pick up where he left off for a national public radio story he did on the same subject 10 years ago. At that time, he interviewed Lori Griffith (now Cline) and Denise Blankenship (now Owendorf) who both generously consented to volunteer again. The web site has a membership of more than 10,000 schools and 1 million students around

the country. ISA will receive a copy of the video when completed.

Then the Maj. Gen. Marion Carl Aviation and Aerospace Education Foundation are seeking women pilots to speak to the Roseburg, Ore., students in two mid and three high schools. They have an enrolment of some 2500 students and can make all or a smaller group available. The Carl Foundation is dedicated to encouraging students of both gender to pursue careers in the field of Aviation and Aerospace. They are trying to keep their speakers as an equal number of men and women. The Foundation can provide transportation from the Northwest and have a guest house on the North Umpqua River. At the moment, they have speaker openings through the end of June 01. March dates are open and would be the first request. May is covered by Capt. Gene Cernan, last man on the moon. Any other time except March 20-27 would be appreciated. If you are interested in participating please email me on [lizjc@worldonline.nl](mailto:lizjc@worldonline.nl) or fax on +31 206716070.

Finally, we have had a request from the Chief Training Captain of Air Malta, Robert Risso, who is writing a dissertation for his masters degree. His is looking at how, though most of an airline pilot's training is dominated by "masculine" values e.g. competence, achievement and competitiveness the CRM domains as listed by ICAO and other organisations are predominantly "feminine" e.g. teamwork and interpersonal relationships. The focus of his research is to find out whether pilots are in fact driven by the masculine values, or whether the feminine values encouraged by CRM are accepted across the board. Captain Risso is hoping to be able to distribute at least 40 questionnaires to our members – please do let me know if you are willing to participate by email, fax or regular mail.

All that remains is for me to wish Tiffany the best of luck and thank all those who have helped in the last year. Thank you, as well, to my predecessor Nanc Briot – blue skies and happy landings to all – Liz Jennings Clark. ➔

## Treasurer's Report, February 2001

Scholarship Fund:  
\$2,700 from Paine Webber was deposited into the Bank of America to cover the 2000 and 2001 Women in Aviation Conference expenses. The BOD agreed that WIA expenses of \$1,500 per year would come out of the Paine Webber account.

BIAS Account:  
This is ISA's "slush" account that earns 5.57% interest. A total of \$2,322 in dividends was reinvested for the year 2000. Feb 1<sup>st</sup>, I transferred in \$8,000 from Alaska Airlines (convention sponsorship), and \$3,800 left over from Costa Rica. As you see in the box insert, right, the money earmarked for convention is now \$28,940.

**Budget 2001:**

The budget for 2001 was approved at the February BOD meeting. Just a reminder: the budget does not include convention income/expenses, or scholarship income/distribution or WIA expenses.

Looking back, there were quite a few necessary (but not budgeted) expenses for 2000. These included: donating \$3,500 to Forum Pictures, printing 5,000 ISA letterhead and 1,000 membership brochures, buying ISA binders, and restocking the ISA store with new merchandise. To alleviate any surprises for this year, I asked each committee member to submit her budget/projects and was pleased at the response. Here is a breakdown of the 2001 ISA Budget:

## Beryl Markham Memorial Fund

In 1998 Stephanie Mays, an American sculptor living in Nova Scotia, Canada, contacted ISA about erecting a sculpture memorial to commemorate Beryl Markham's historic 1936 East to West solo flight across the Atlantic. (Who was Beryl Markham? See the article on the back page of the Newsletter for a brief biography.) Beryl landed in Nova Scotia, but nothing has ever been erected there to commemorate the event. Ms. Mays completed a clay model, and wanted to know if ISA was interested in publicizing and helping raise money for the memorial.



As then Communications Chair, I volunteered to take a look at the project: consulted with the artist, talked to other aviation groups such as the Ninety-Nines, Inc. and Women in Aviation. The ISA Board, deciding that ISA was in the best position to take the lead on such a project, approved the establishment of the Beryl Markham Memorial Fund. Contributions to the Fund are tax deductible using ISA's EIN number 52-1465669.

Ms. Mays' South Carolina cousin can make the mold. With the help of Val Thal-Slocum, Federal Express, we found an Arizona bronze foundry to do the bronze work. We project needing to raise \$30,000(U.S.) to cover the cost of mold making; bronze relief casting; insuring, shipping and mounting on granite in Nova Scotia. (Photos this page are artist renditions of finished memorial). As the bronze portion of the memorial nears completion, we will need to establish liaison with local authorities to choose a memorial site.

Ms. Leslie Negley of San Antonio, Texas, who I met on one of my UPS trips through San Antonio, jumpstarted the Memorial Fund with a very generous donation of \$5,000. Leslie is not a pilot. She is the mother of two children, and comes from a ranching family. We were talking about my work, women pilots and ISA when the subject of Beryl Markham came up. You never know where a casual conversation is going to lead!

Before we can authorize the mold making, which needs to be completed by end of 2001 to fit with the artist's schedule, we need a minimum of \$10,000 in the Fund (current Fund balance is approximately \$5,000.)

Alaska is a virtual sub-continent twice the size of Texas and contains 16% of United States land area. Anchorage is the largest city in Alaska with a population of 250,000. It covers nearly 2,000 square miles from Portage Glacier to Turnagain Arm of Cook Inlet to the historic village of Eklutna. The municipality contains more than 500,000 acres of preserved parkland and miles of Alaska's most spectacular wilderness. Protected by the Chugach Mountains and warmed by the Japanese currents of the Pacific Ocean, Anchorage has a temperate maritime climate.

In short, Alaska is like nowhere else - wild, extreme, and amazing. We look forward to welcoming you to this inspiring destination.

### Getting There: Anchorage airport (ANC)

Alaska Airlines is the flagship carrier. Domestic airlines include America West, Northwest, Continental, Delta and United. International airlines include Asiana, Cathay Pacific, China Airlines, EVA Airways, Korean Airlines, and Reeve Aleutian. Atlas, FedEx, Gemini, and UPS are cargo carriers that offer jumpseats.

### Direct Flight Entry Points

Entry points for direct flights to Anchorage are Los Angeles, Chicago, Minneapolis, Portland, OR, and Seattle. Seattle, on average, offers 18 flights daily into Anchorage.

### Alaska Airlines Special Convention Rate

Alaska Airlines has offered any member and eligible dependents a standby pass leaving out of LAX, SFO, and SEA, to ANC for \$60, plus Alaska tax. This offer is good for two weeks prior to two weeks after the Convention. To purchase tickets, send a self-addressed envelope to Alaska Airlines, c/o Employee Travel, P.O. Box 68900, Seattle, WA 98168, accompanied by a written request from your airline pass bureau or a form validating your employment.

Send the request a minimum of two weeks prior to your anticipated travel date. Alaska Airlines will return the authorized form to you to purchase the ticket at an Alaska Airlines ticket counter. You will also be required to show your airline ID.

**Climate:** This time of year is still cold, with an average high of 54° F (12° C), and low of 38° F (3° C). You can also expect over 17 hours of daylight. Warm clothes will be necessary, and don't forget to bring the binoculars.

### Transportation: Airport to hotel:

**May 8th** - The Magic Bus (telephone 907-268-6311) will have group pick-up times of 2 p.m., 5 p.m., 8 p.m., and 11 p.m. This bus will cost each passenger approximately \$25 per transfer. You will pay the Magic Bus directly. We can also arrange individual pick-up times, but this may cost more depending on the number of passengers. Please sign up for a group pickup time or request an individual pickup time on the Registration Worksheet.

**May 10th & 11th** - Shuttle departure times to the airport are 8 a.m., 10 a.m., 12 p.m., and 2 p.m. Upon check in at the hotel, we will have a sign-up sheet for departure return times to the airport. These times are considered reservations, so if your plans change, you will need to notify Magic Bus, otherwise you will be charged for the transfer. Again, we can arrange individual/group departure times on the 10th/11th or thereafter. The cost is the same as the pick-up. Please remember that this lodging location is unique and will not have all the amenities, such as hourly service to the airport, that you may be used to in larger cities. It takes some extra planning and cost, but it is will worth it.

apartment belonging to a 767 international captain and his wife who are good friends with Luba Rylova. The captain was out on a trip so we did not meet him. Our hostess, Nadia, put out an incredible spread with potatoes, pork goulash, black caviar, etc. It was a most delicious Russian meal. We saw pictures of their lovely country dacha and Jeep Cherokee. Their three children were there and all spoke good English. The oldest son, Andrei, is an Aeroflot pilot on the TU-154, like the B-727. Luba Rylova's son Alex, a good friend of Andrei, is working as a pilot in Russia and building flight time.

The next day we toured the Tretyakov Gallery, which houses the largest collection of Russian art in the world. It is superb, and we saw just a portion of its displays. We went to a matinee concert at the Bolshoy Theater. The orchestra was world class and towards the end, three outstanding tenors belted out several songs that whipped the crowd into many encore requests.

The closing ceremony for the Forum was that afternoon, and as part of the meeting, Linda and I gave short speeches, translated by our faithful interpreters, Anya and Valodia. Ruth, a teacher like Debbie, called her up front to sing the US national anthem in front of 200 people! Everyone loved it. ISA member Natalia Vinokurova, of Magadan, Russia, gave a short speech to her colleagues and was warmly applauded.

That night Linda and Luba came over for dinner at Valodia's family home, where his mother Luba and father Mikhail, a jeweler, offered us wonderful food and hospitality. Luba, a tall blonde woman, works at Aeroflot with Luba Rylova and came to ISA in Las Vegas. Lucy remembered her from the ISA side trip to the Grand Canyon, where we enjoyed many Vodka toasts and managed to narrow the language barrier! They have a BMW 318, and Mikhail gave us a night city tour by car.

Our last day, Linda caught an early flight out and Debbie and Lucy caught a ride with Valery and Galina to the airport. Galina

was extremely gracious. Linda had a good time with the Air France crew watching the departure from Moscow. She enjoyed using her Russian with the families that she visited in Moscow. The Delta flight to New York had many Russian youngsters dying to use their English so we chatted with a few of them.

Commercially, Moscow has improved dramatically, with lots of brightly-lit stores, Christmas decorations, and little grocery stores. Car ownership has quadrupled. The city underwent major renovations in 1997 in honor of Moscow's 850<sup>th</sup> anniversary. The Alexander Garden next to the Kremlin has a huge underground shopping mall nearby. The shops were high quality merchandise and relatively expensive, as one would see in a major European city. The Russians celebrate the New Year on Dec. 31, before the Russian Orthodox Christmas on January 7. We brought back Santa matrioshka dolls and tree ornaments as souvenirs. Our hosts and hostesses gave us such nice gifts, that we look forward to returning the hospitality some day soon. →

## International Report-Russia Aviatrix Forum 2000

The Fourth International Moscow Forum of Women Pilots convened December 1-3, 2000, and ISA members Lucy Young and Linda Wright were fortunate to be able to attend this wonderful event. Obtaining the Russian visas brought back fond memories of the 1993 ISA trip to Moscow, spearheaded by Vickie Karnes, during which 25 ISA members and their guests attended the first Aviatrix Forum. Lucy and Vickie had also hosted Galina Korchunagova, Aviatrix President, in Atlanta in October 1999.

Lucy and her friend Debbie Hildebrandt departed on Delta from BOS-JFK-SVO, and

ISA member Ludmila Petrash (bottom photo) met us at the hotel, after which we went next door to the Veteran's memorial building for the Forum events. At the opening meeting, we met two 19-year-old students, Anya and Valodia, who volunteered to translate for us. They were with us practically the whole time we were touring. They must have been exhausted, but appeared grateful for the chance to practice speaking English. Ruth, the translator from 1993, was there too, and helped at the opening and closing meetings. She is an English teacher in Moscow.

A representative of the Duma, Valery, spoke at the opening meeting, then invited us to the Duma. It is like the House of Representatives, and the Parliament is like the Senate. Seven of us visited his office, it turned out that he and his office mates are staff assistants on an aviation committee. One of them had flown for Sakha Air in eastern Russia, which he pointed out on a huge wall map. We met Luba (see photo, left), her daughter Nadia and her husband at a chain restaurant with a name sounding like "Hokey Pokey." They had a food bar that was delicious, plus good borscht. Thank you Luba, for this delicious feast!

The next day Valodia and Luba met us for a tour of the Kremlin and the Alexander Garden. Valery met us later and drove us to his country house ("dacha") where we met his wife Svetlana and had a delicious happy hour. That night we ate at a gorgeous and spacious

They have a big red "1" on the front for one way (five rubles) and a blue "2" for round trip (10 rubles). As in many cities, the big "M" is the metro symbol. St. Basil's cathedral looked beautiful with a light dusting of snow. Ludmila was speaking good English, thanks to Nancy Novaes starting her out in New York after the Vancouver ISA convention. She is still grateful to Nancy - good job N2!*

## Financial First Steps When Grieving the Loss of a Spouse

Your finances certainly aren't the first things you think about if you've lost a spouse. Eventually, though, there are important money matters to handle. The good news is that you don't have to tend to them alone. A trusted financial advisor, working with the family attorney, can help with the financial tasks that must be done - and that person is a

resource you can continue to count on as you recover from your loss. Some of these first steps include:

- **Arrange for funeral costs.** Among the most immediate details that will need attention is funeral planning. If funeral costs aren't already covered, you may want to use cash assets held in a joint bank, checking or money market account to pay the expenses. If your spouse prepaid part or all of his or her funeral costs, a funeral agreement should provide all the details. If the document is not available, contact the funeral home and/or cemetery for a copy.

If the spouse was a military veteran, he or she and any dependents are entitled to free burial in a national cemetery. If you prefer a different cemetery, the government will still pay some expenses for vets who were receiving VA disability payments at the time of their death.

- **Inventory assets.** Once the funeral is over and you've had some time to grieve your loss, you'll need to take an inventory of all your spouse's assets - both those you held jointly and those in the deceased's name only. These assets may include bank and investments accounts, real estate and other tangible property, employee pensions and other benefits, government benefits and life insurance.

Jointly owned property and assets, such as pensions, IRAs, 401(k)s, life insurance proceeds and your home, will pass to you outside of probate. Keep in mind, however, that joint assets will increase the size of your estate and may be taxed at your death if your estate reaches certain levels. Before accepting these assets, you may want to consult your attorney to learn all your estate planning options.

If life insurance is among the assets, send a death certificate and claim for



benefits to the insurer as soon as possible. There may be decisions to make here, too, since benefit payout options often include a lump sum or annuitized payment over time.

Likewise, you'll want to keep your overall picture in mind when deciding on employee pension and benefit options from your spouse's employer. These may include life insurance, vested retirement pension or 401(k), stock option and stock purchase plans and medical insurance. If you were covered by your spouse's company medical insurance, be sure to apply for continuation of coverage under federal COBRA rules within 60 days. For more information on your benefits choices, contact the company's human resources department.

- **Apply for Social Security benefits.** Contact the Social Security Administration by telephone (800-772-1213) or at the agency's local office to report the death and apply for survivor benefits. Such benefits include a one-time death benefit of \$225 and possible ongoing survivor benefits. The amount of the monthly benefit is based on the earnings of the deceased. The more he or she paid into Social Security, the higher your survivor benefit will be. Widows or widowers age sixty-five or older get 100% of the deceased's basic Social Security benefit, while those age sixty to sixty-four get about 71-94% and widows at any age with a child under age sixteen receive 75%.

You also may be eligible for military veteran's benefits, if your spouse was a veteran. These may include pension payments and financial aid for education costs. To learn more, contact the U.S. Office of Veterans Affairs at 800-827-1000.

Manage the deceased's estate. If you and your spouse did not own everything jointly, probate may be required. Your attorney can assist you with the process, and specific tax issues, which may take from several months to more than a year, depending on the complexity of the situation.

- **Update your financial and estate plan.** The death of a spouse is likely to create some big changes in your life - both financially and emotionally. Once you're on your feet again and have attended to the more pressing financial tasks, consider taking some time before making other big financial decisions.

Eventually, though, you'll want to review your financial and estate plans in light of your new situation. Here's where your financial advisor and attorney can be invaluable - by looking at your overall situation, need and goals, and making suggestions that will help you move on in life without worrying if affairs are in order.



Beryl Markham became the first woman in Kenya to receive a commercial pilot's license. She decided to try for the prize of flying solo from London to New York. Such a flight had never been accomplished because it meant flying against the prevailing winds.

She borrowed a single-engine Vega Gull with a 200-horsepower engine—that could fly up to 163 miles per hour and that was fitted with extra tanks so it could travel 3,800 miles without refueling. The plane had no radio equipment.

Markham left London at 8:00 P.M. on September 4, 1936, facing a strong head wind, low clouds, and blustery weather. She was seen over Ireland at 10:25 P.M.; at 2:00 the next afternoon she was spotted by a ship in the Atlantic; and at 4:35 P.M. she was reported to be flying over the tip of Newfoundland. Then she disappeared. A telephone call from a small town in Nova Scotia finally brought news of the aviator. She survived her trip, but had crash-landed in a peat bog. With the nose of the plane stuck in the mud, she had climbed out and greeted two fishermen by saying, "I'm Mrs. Markham. I've just flown from England."

Disappointed that she had not managed to fly all the way to New York City, Markham was afraid the flight would be considered a failure. In fact, news services carried the report throughout the world, and she was hailed as a heroine. She met New York Mayor LaGuardia and rode in a city motorcade. Markham returned to England to find she had become a celebrity. She lived there for the next few years but did not take up flying again.

### **Beryl Markham, English aviator**

Her flight across the Atlantic had almost ended in tragedy when the fuel line to one of the plane's tanks froze, causing the engine to fail. Just before Markham reached the sea, the line warmed up and the fuel started to flow again, allowing her to pull up. Another frozen fuel line caused her to crash in Nova Scotia.

In 1939 Markham moved to the United States. Her book, *West with the Night*, published in 1942, tells of her childhood in Kenya, her unconventional bush pilot career, and her pioneering transatlantic flight. For a number of years Markham lived in California, where she remarried and ran an avocado ranch. In 1952 she returned to Kenya and took up the career she had started thirty years before—raising and training horses. She died in Kenya in 1986 at the age of 84. ➔
